Article VI: Modify first paragraph to read as follows:

An annual A meeting for the election of Directors and Officers of the Association shall be held at the first meeting in January each year annually.

Article VII: Modify as follows:

The affairs and business of the Association shall be managed by a Board of at least ten (10) six (6) Directors of which four (4) shall be the Officers of the Association and the additional six (6) two (2) or more shall be those elected an the annual meeting by a majority vote of the members present. Such Directors shall serve on a volunteer basis and without remuneration for the ensuing year or until their successors have been elected and qualified.

In a way I was relieved due to CDC recommendations and common sense regarding the dangers of group meetings.

My thoughts were to arrange potential speakers and record their presentations in a sound studio or their place of business. As dates and topics were in the planning stages, there came layoffs, furloughs and surging virus case counts. We then had to improvise and find another alternative to keep the program going.

What has come about through our field research is to utilize what is safe and available on the internet. So, we created a *Virtual Library* for our membership. It is available on the Association's website:

The site is continually growing and evolving. We are learning as we go to find topics that our neighborhood can relate to and find meaning in each presentation.

Neighborhood Updates:

CC&R's Architectural Committee

The original South Shores developer administered the CC & R process for 4 tracts within the neighborhood. In the mid 1960's, the then-named South Shores Homeowners Association voted to take over the administration of them from the developer. Given that the tracts identified have been built out and few owners living in them have sought interest to support or continue engagement with SSCA on facilitating these regulations, in 2020, the Board of Directors dissolved its Architectural Committee and will no longer administer them.


LA County Sanitation District's Clear Water Project

This important project, that will impact our neighborhood, has been in the planning stages since 2006. It has been discussed with the SSCA Board, at Annual Meetings and in past editions of the VIEW POINT newsletter. In 2019, construction started within the County's sewage treatment plant facility in Carson, just east of the Harbor Freeway. The 20 foot diameter, 7 mile long, tunnel will eventually be constructed below Western Avenue and end in the Royal Palms area. Direct construction impacts on our neighborhood will not occur until mid-2024 at the earliest.

South Shores Magnet School Improvements

This LAUSD project to remove relocatable classroom buildings ("bungalows") and to build a two story classroom building was discussed and approved for construction in 2019. School Principal, **Dr. Paul Suzuki**, reports that preliminary work has been completed and construction on the new building will begin later this year.
